#### Business and Business-Related News for Economic Development Region 6E: April 2024.

**DEED News:** DEED announced more than \$2.2 million in land redevelopment funding to eight communities statewide – creating or retaining 91 jobs, collectively increasing local tax bases by \$3.1 million and leveraging more than \$228.7 million in private investment. The Redevelopment Grant Program helps communities with the costs of redeveloping blighted industrial, residential, or commercial sites and putting land back into productive use. The Demolition Loan Program helps communities with the removal of dilapidated or unsafe structures to prep sites for future development. Hutchinson was awarded a grant!

**Hutchinson: Jorgensen Hotel** The city of Hutchinson was awarded \$150,000 in Redevelopment Grant funds for demolition on this 0.26-acre site. Built in 1916, the existing Jorgenson Hotel has been home to a bank, restaurant, drug store, bowling alley and apartments. After the original hotel burned down, it was rebuilt using large amounts of concrete, which has proven to be costly for past redevelopment attempts. The current plan is to demolish the site and redevelop it into a new hotel. It is anticipated this project will create six jobs, increase the property tax base by \$121,200 and leverage \$8 million of private investment. Matching funds will be paid by tax increment financing and the developer.

#### Hutchinson and Litchfield Newspaper closing:

Hutchinson Leader will cease operations April 28, bringing an end to its more than 140 years of service to Hutchinson and the McLeod County area. The Leader's shopper companion, Weekend Leader Shopper, and its sister publications, the Litchfield Independent Review and Meeker County Advertiser, and the Crow River Press printing business also will close. The Leader and Independent Review, like many newspaper businesses around the country, have been challenged during the past decade or longer by changing lifestyle habits, especially by the dramatic shift in advertising revenue from local print publications to digital options such as Google, Facebook and Amazon.

**CherryRoad Media taking over for the Hutchinson Paper**: CherryRoad Media, the media division of CherryRoad Technologies of Parsippany, New Jersey, has announced it will be opening two new community journalism operations, the Litchfield Rail and the Hutchinson Station, with publication of the new newspapers to begin May 9. Staffing the new community newspapers will be previous editorial and advertising staff from the Leader and Independent Review, including Editor Brent Schacherer, who has been doing journalism in Hutchinson and Litchfield for 25 years.

**Ridgewater College news:** The Customized Training department at Ridgewater College is excited to introduce three new entry-level, accelerated training programs this summer: **welding**, **limited energy**, **and carpentry**.
